- Main Tasks, Responsibilities and Scope of Work**

- The empaneled external editors and proof-readers shall have to do the editing and proof-reading of publications as per standard guidelines and in-house style of the ICAR.
- The editing and proof-reading of publications will be assigned to one or more empaneled editors and proof-readers depending on the quantum and priority of work.
- The editing and proof-reading work will be assigned to the empaneled person(s) on the basis of approved rates of ICAR.

- Time Frame**

- The empanelment of editors and proof-readers is valid for three years i.e. 20.01.2025 to 19.01.2028 which can be extended for a period of one year or more as deemed fit as per requirement and urgency of work. The empanelment of any editor/proof-reader can be discontinued at any time during the empanelment period with the approval of PD, DKMA.

- Deliverables**

- The editors and proof-readers on panel are expected to deliver/supply the edited/ proof-read version either in the form of hard copy or soft copy as per the editorial standards/guidelines and in-house style of ICAR. The stipulated timeline for completing the assignment shall be as under:

- Monitoring of the quality of editing and proofreading**

- The quality of editing and proof-reading work will be judged by the concerned In-charges and Project Director, DKMA.

Ranjan

- In case the quality of work done is not satisfactory, the editor/proof-reader may be asked to make necessary modifications/improvements in a time bound manner without any extra payment.
- Editor/Proof-reader may be removed from the panel in case of non-completion of the assigned work in time or unnecessary delay or continuously failing to maintain the quality of the work done.
- **Rates**
 - All the empaneled Editors and Proof-readers will be paid remuneration for the assigned work of Editing and Proof-reading as per the approved ICAR rates for editors/proofreaders vide D.O. No. 25-7-2014-EEU dated 16.03.2020 of ICAR-DKMA: -
 - a. Rates for Editing – Rs.50/- per manuscript page.
 - b. Rate for Proof reading – Rs. 15/- per page three times.
- **General guidelines**
 - The empaneled editors and proofreaders can do the assigned work at their convenient place.
 - In case of urgency, empaneled editors and proofreaders can be requested to complete the work at DKMA in time bound manner, failing which appropriate action will be taken.
 - The existing panel will become infructuous on the implementation of new panel.
 - The name and logo of ICAR shall not be used on the empaneled editors'/ proof readers' visiting cards and other communication material.
 - No other facility except the approved rates will be payable to the assignees.
 - The Project Director, ICAR-DKMA, reserves the right to withdraw the Editing/Proof-reading work or cancel the entire panel at any stage. The decision of the PD, DKMA in all matters will be final and binding on the Editors and Proof-readers.
- **Guidelines for editing and proofreading**
 - The manuscript is the sole property of ICAR, anyone found misusing it will face the legal consequences to core entrenchment.
 - Editing of ICAR books needs checking of scientific names from <https://www.ipni.org/> (for plants) or <https://www.sciname.info/> (other organisms) along with proper use of grammar as well as usage and abuse, punctuation, and spell check.
 - Use SI metric system of units, i.e. meter, kilogram, second. In case of data given as acre and pound these may be converted as 1 acre = 4,047 square meters (0.405 hectares), 1 pound= 0.404 kg.
 - Placement of tables, figures, captions should be at the relevant place.
 - In case illustrations have international boundary, it is necessary to indicate courtesy. Check if author has obtained permission from Geographical Survey of India.
 - Cross check references from the text of the book and standardize the references.
 - Give table no. as 1,2,3; and the numbers should correspond with those given in text.
 - Strictly follow the style of Reference presentation as given below:
 - a. **In text:** Black (1971) or (Black 1971); Dickerson *et al.* (1974) or (Dickerson *et al.* 1974), (Smith and Jones 1974, Smith and Jones 1977). Groups of references cited in a sentence in the text must be listed in chronological order as in the previous sentence.
 - b. **In list:** Full name of journal in italics, volume no. in bold, pp range, e.g. 112-23). References list should be typed in alphabetical order. The reference list should be first sorted alphabetically by author(s) and secondly chronologically.
- **For Journal Articles**
 - Author(s). Year. Article Title. Journal title (full name in italics) volume number (bold): page-page. Aparna K, Rao D L N and Manna M C. 1980. Microbial inoculation of chickpea (*Cicer arietinum* L.) enhances rhizosphere effects on soil biological quality. *Agrochimica* 58(2): 114-125.

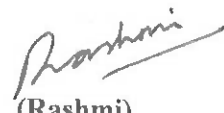
