Office Order

In continuation of the earlier Office Order No. DKMA/1(1)/2025-BU dated 26.06.2025, vide which the rates of ICAR publications, subscription policy of ICAR Publications namely Magazines & Journals, etc. were revised with the approval of the Competent Authority, ICAR. The ICAR has further reconsidered the subscription policy of ICAR publications, as circulated vide O.O. dated 26.06.2025, after taking into consideration of future visibility, impact, and outreach of ICAR publications and decided that the revised subscription policy for Indian Journal of Agricultural Sciences (IJAgS) and the Indian Journal of Animal Sciences (IJAnS), as well as the popular magazines viz. Indian Farming (IF), Indian Horticulture (IH), *Kheti*, and *Phal-Phool* shall be as follows:

**Single-Author Subscription Model**

i. Only **one author per article**, either the corresponding author or any co-author, shall be required to hold an active annual subscription on payment of **₹3,000** (US \$300 for Foreign/International Authors) for Journals such as Indian Journal of Agricultural Sciences (IJAgS), Indian Journal of Animal Sciences (IJAnS) and **₹500** for Magazines (Indian Farming, *Kheti*); **₹250** for Magazines (Indian Horticulture, *Phal-phool*) at the time of acceptance of the respective article by this office.

**ii. Waiver of Subscription Clause for Foreign / International Authors**

- Subscription fee may be waived-off for Foreign/International Authors **only in cases of genuine financial constraints**.
- Such waivers shall be applicable to authors from **underdeveloped countries**, strictly on a **case-to-case basis** and subject to approval of the **Competent Authority of ICAR-DKMA**.
- Subscription waiver shall be applicable **only for non-funded research publications/articles**.

The O.O. dated 26.06.2025 shall be revised to the above extent only. The revised subscription policy shall be effective from the date of issue of this office order.

The Office Order of even number dated 15.01.2026 stands withdrawn.
